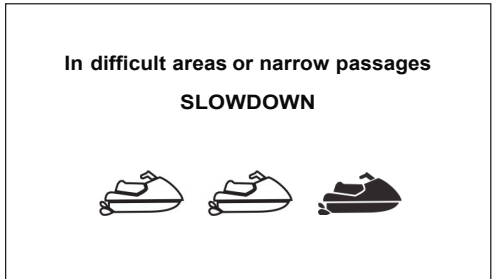
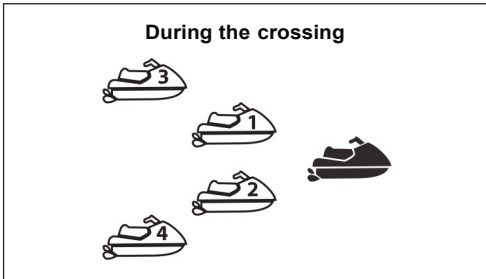

NAVIGATIONAL RULES AND REGULATIONS

The customer is obliged to:

1. Respect the referenced safety standards, as well as any regulation established by law of general interest, being responsible for any administrative sanction that may be imposed on the Company that owns the Jet Ski due to the client's negligence.
2. Pay attention and follow the orders of the monitor at all times. It is strictly forbidden to surpass the leader of the group, except when indicated.
3. Keep a safety distance of 50 meters between the boats and the Jet Ski during the trip.
4. It is expressly forbidden any kind of race between the Jet Ski drivers.
5. Wear a lifejacket at all times, both driver and passengers.
6. Reduce speed if a vessel is within 100 meters of distance.
7. Reduce speed completely when the Jet Ski is within 200 meters of the shore.
8. Check the position of the other vehicles while navigating before making changes of direction and never within 200 meters of them.
9. In case of confusion or if you are unable to control your Jet Ski, pull the key cable that disconnects the engine, and wait for the monitor to come to your rescue, without leaving the Jet Ski at any time.
10. Before starting navigation, make sure to understand these rules and the operation of the Jet Ski, clarifying any doubts or questions with the monitor.
11. For your safety, the navigation will be in groups and as follows:

TERMS OF THE CONTRACT

1. The Customer declares at his own risk that:

- a) He is at least 16 years old and has parental consent for the activity.
- b) He is in good physical and mental conditions to drive the jet ski, and that it has been delivered to the Company in proper conditions of use and without any damage. If the Customer is under the influence of alcohol and / or drugs, the Company may cancel the present Contract without any obligation to return the amounts paid for the activity, and without any right of claim.
- c) He has received adequate instructions on how to operate the Jet Ski and has been provided with life jackets for safety, knowing that their use is mandatory.

2. The user agrees to read and follow the navigation and security rules of this contract. If they violate any of these rules, they will be liable to the Spanish authorities in case of civil liability and the contract will be cancelled immediately, without any right to claim or compensation.

3. The Jet Ski driver shall assume all civil and penal liability, resulting from willful or reckless driving.

4. The Client acknowledges having received the necessary instructions for the handling of the Jet Ski from the center's guides, and the jet ski is delivered in good conditions. He undertakes to return it in the same condition s. If not, the Company reserves the right to claim financial compensation for damages from the client.

5. It is expressly agreed that the Company assumes no liability whatsoever for loss or damage to any personal property stored on the vessel by the hirer or accompanying persons, whether during or after the end of the charter.

6. The client must arrive at our installations 15 minutes before the time of booking. If he does not arrive on time, he will forfeit the jet ski rental and no payment will be made . The booking time is approximate and can change due technical reasons or bad weather, without any right to claim and compensation.

7. If the Client decides return before the scheduled end time of renta1, he will not receive any refund.

8. The user assigns all his image rights, without territorial limitation, deriving from recordings or images taken during an activity offered by the Company, with the maximum legal duration established for intellectual property rights and for any product advertising and for promotion of the website www.gojetmallorca.com, as well as social networks of the Company for any media.

9. For any questions arising in relation to the fulfillment of the clauses of this Contract, the parties expressly submit themselves to the Courts and Tribunals of Inca, to the exclusion of any other jurisdiction that may correspond to them.
